Procedure - Drummed Waste Collection

Introduction:

This is a site-specific method statement undertaken prior to the activity commencing.

Objective:

Ensure that the waste is prepared in a safe secure manner, in accordance with the Carriage of Dangerous Goods ("CDG 2009"), SI 2009 No 1348.

Management Controls:

To maintain a safe working environment the following must be adhered to:

✓ Site Induction:

To Mitigate Health & Safety risks

Clarify the driver understood their induction and meet the site compliance.

✓ Method Statement Monitoring:

Observations of all persons involved ensuring the RAMS are being adhered too.

✓ Checks:

Whilst working continuously reference the written procedure

✓ Reporting:

Of all accidents/ incidents or near misses.

Driver Requirements:

- ✓ Licensed for HGV Class 1
- ✓ ADR trained
- √ Vehicles must be correctly marked with plates front/ rear & suitable for purpose

Documentation:

All relevant & supporting documentation must be carried

- ✓ Consignment Note(s)
- ✓ Conveyance labels identifying waste materials adhered to individual containers
- ✓ Instruction(s) in Writing
- ✓ DGSA incident report procedure, provided on request

Vehicle Equipment:

- ✓ Fire extinguishers regulations
 Approved standard, Sealed to show unused, Show the inspection date (if manufactured after 01.01.1997)
- ✓ First aid kit
- ✓ Eye rinse bottle
- ✓ Spill Kit

Personal Protective Equipment:

- ✓ Safety foot wear
- ✓ PVC gloves
- ✓ Eye protection
- ✓ Hi visibility clothing
- ✓ Hard hat (Site specific)

Please Note:

- Remove all previous labels, allowing for clarity of identification in the event of an accident
- Labels must be clearly legible when the container is in transport position & stand out from the background & be readily noticeable
- Be clearly indelibly printed on a securely fastened label

Drummed Waste Collection:

There must be **No Smoking** in the cab or vicinity of the vehicle or use of a mobile phone.

- ✓ Adhere to site speed restriction & park in contractor designated area(s)
- ✓ Sign on site & proceed to notify all relevant personnel
- ✓ Adhere to site Health & Safety rules at all time
- ✓ In the event of an emergency evacuation of the site; contractors CANNOT move their vehicle from where they are working; but must follow WZ Packaging Ltd staff to the nearest Muster Point.
- ✓ Park vehicle as instructed in the loading location
- ✓ The driver must always leave the parked vehicle with the handbrake on & engine switched
 off during loading
- ✓ Change into PPE
- ✓ Open curtains & secure to prevent any injury
- ✓ Check all documentation is valid and the load is as describe on the consignment note(s), any discrepancy must be addressed prior to loading
- ✓ Place orange marker boards on vehicle
- ✓ No containers will be opened without authority
- ✓ All containers will be checked visually for integrity, any defective containers should be either corrected or rejected
- ✓ The integrity of all pallets must be checked any defect pallets must be replaced.
- ✓ Visually check all replaceable closure are fastened securely
- ✓ Make certain the containers have identifying conveyance labels.
- ✓ Check with person co-ordinating the removal of waste is ready, then proceed to load the materials
- ✓ A fork lift truck will the locate the drummed waste in a safe position on the vehicle
- ✓ Check before and whilst loading the listed materials correspond with the consignment note(s)
- ✓ Loading operation must be monitored closely providing the opportunity to contain any emergency situation that might arise
- ✓ Keep a safe distance from the fork lift truck
- ✓ All personnel involved must load vehicle safely
- ✓ Complete all consignment note(s)

Prior Leaving the Customers Site:

Check vehicle is prepared for the road:

- ✓ All relevant identifying marker boards are being displayed
- ✓ Consignment note(s) are correctly & fully completed
- ✓ Inform the relevant personnel prior to leaving site then proceed to signing out

Whilst Travelling:

- ✓ Keep constant watch for leaks etc....
- ✓ Drive with due care & attention
